#### ENROLLMENT AGREEMENT / PARENTAL CONSENT

#### Name of Child:

- 1. Cooperation: We have read and agreed to the content of the Parents' Handbook and hereby commit to cooperating with the school in all matters concerning the care and education of our children.
- 2. Attendance and Punctuality: We acknowledge that our children will attend school regularly and we will notify the school in advance of any planned absences. We will ensure that our children arrive before 7:45 a.m. and are promptly collected at the end of the school day. We understand that consistent tardiness may result in disciplinary measures or fines imposed on parents.
- 3. Dress Code: We agree to ensure that our children come to school dressed appropriately in accordance with the school's uniform policy as outlined in the Parents' Handbook.
- 4. Pupil Absence: We understand the importance of informing the school about any absence of our children and commit to notifying the school before 8:30 a.m. on the first day of absence, providing the reasons for their non-attendance. We will not send our children to school if they are unwell and unable to participate in lessons.
- 5. School Fees and Payments: We acknowledge our responsibility to promptly pay the school fees as required. School fees must be settled within the first 2 weeks of each term or within 2 weeks of enrollment. Failure to pay fees within this timeframe may result in the child's withdrawal from attendance, unless alternative arrangements have been made with the school.
- 6. Medical Treatment and Care: We grant permission for our children to receive first aid and emergency medical attention from the school's nurse or another capable adult.
- 7. Emergency Treatment: In the event of a medical emergency requiring immediate action, we consent to the school arranging for our children to be taken to the nearest reliable hospital at the expense of the parents.
- 8. Accurate Details: We confirm that all enrollment information provided to the school, including the date of birth of our children, is accurate. We agree to provide all required documentation and promptly inform the school of any changes in details such as address and contact numbers. We understand that providing incorrect information may result in our children being denied enrollment.
- 9. School Trips: We give consent for our children to participate in all local school trips, subject to payment being made where applicable.

- 10. Respecting Property: We agree to be responsible for any school books or other items that our children may lose or intentionally damage while in their possession. We understand that we are required to cover the costs of replacing lost items or repairing intentional damages.
- 11. Photographs: We grant permission for photographs of our children to be taken and used for school records, marketing, and publicity purposes, including on the school website, in leaflets, and yearbooks.
- 12. Security Cameras: We acknowledge that the school utilizes security cameras for monitoring purposes and to enhance security. We consent to our child being recorded on security cameras.

We acknowledge that failure to accept discipline for poor behavior may result in the exclusion of our children from school. The Head Teacher has the final authority on disciplinary matters and reserves the right to apply any reasonable sanction deemed necessary.
